  - IV. Financial assistance will be awarded based on determination of a financial assistance committee. Applications which are not completed by the appropriate date will not be considered.
  - V. The Foundation does not discriminate against any applicant because of race, religion, color, sex, national origin, or handicap.
  - VI. The Foundation will require receipts for the reasonable expenses incurred by financial assistance recipient while attending the designated golf tournament.
  - VII. Financial assistance will be distributed after the receipt of required documentation of participation and expenses. Completed applications will be accepted quarterly.
